Brief summary of the content of the workshop	The workshop looked at language teacher competencies in order to get an overview of the competences needed as well as to provide an access to the examples of descriptions of competences in the existing tools and frameworks. As the number of the latter is big, one aim of the project was also to bridge the gaps between them.
What did you find particularly useful?	For me the most valuable was the overview of already existing frameworks of language teacher competencies as we are currently looking through our curricula. Having a good overview of these competencies helps us to update the learning outcomes in the language teacher training module. I also found discussing issues and problems related to language teacher education with colleagues really useful.
How will you use what you learnt / developed in the event in your professional context?	While reviewing the syllabi and outcomes of the courses on our language teacher training programme we will consider suggestions offered in the proposed document as well as the competencies described in already existing documents
How will you further contribute to the project?	I haven't thought about my further contribution yet.
How do you plan to disseminate the project? - to colleagues - to a professional association	I have introduced the project as well as language teacher competences described in various documents to my colleagues at our staff meeting. I'm also planning to disseminate the information to colleagues at a foreign language teachers' conference.

ECML projekti "Towards a Common European Framework of Reference for language teachers" keskendus keeleõpetajate pädevustele. Pädevusi vaadati viies erinevas kategoorias: professionaalsed väärtused ja põhimõtted (*professional values and principles*), ained (*subjects*), õpetamine (*pedagogy*), koostöö teiste osapooltega (*cooperation with stakeholders*) ja õpetajate ettevalmistus ning elukestev õpe (*teacher education and lifelong professional development*). Projekti meeskond oli kokku pannud nimekirja juba eksisteerivatest dokumentidest/raamistikest, kus kirjeldatakse keeleõpetajate aga ka vastava eriala üliõpilaste pädevusi ning tööks vajalikke teadmisi ja oskusi (vt

https://www.ecml.at/Portals/1/5MTP/Bleichenbacher/CEFRLT%20list%20of%20instruments.pdf). Projekti käigus on plaanis leida nimetatud dokumentidest ühisosa ja kõige olulisemad pädevused, mida iga keeleõpetaja peaks omama. Samuti soovitakse tuua näiteid juba eksisteerivatest praktikatest. Muuhulgas vaadatakse ka selliseid aspekte nagu LAK-õpe (CLIL), migrantide õpetamine ja viipekeel. Projekti lõppeesmärgiks on välja selgitada, kas dokument *Common European Framework for Language Teachers* on vajalik ning kui jah, siis milliseid pädevusi see peaks sisaldama ning milline peaks välja nägema lõpp-produkt. Projekti meeskond selgitas erinevates kategooriates (vt eespool) olevaid pädevusi ning palus osalejatelt selle kohta tagasisidet. Kuna projekt on alles algusjärgus, siis toimus kahe päeva jooksul väga pingeline arutelu, mille käigus tõstatus hulgaliselt küsimusi, sh ka see kas selline dokument/raamistik on üldse vajalik.
