Brief summary of the content of the workshop	This document offers a concise summary of the approaches to curriculum planning, teaching, assessment and teacher education adopted in the Common European Framework, presents the main principles of using or implementing QualiMatrix, Quality concepts as well as the procedures of planning curriculums, courses, lessons. This project allows us to consider teacher education from different points of view. It touches upon the main approaches to language teaching, emphasises the collaborative nature of teaching.
What did you find particularly useful?	I thing all the stages and procedures of implementing QualiMatrix are worked out properly. All the concepts are defined taking into consideration their content and functional characteristics. It is important that the concepts are defined and qualimatrix characteristics are exemplified in an activity. As to indicators, standards and benchmarking we can say that they are defined and exemplified with vivid examples and illustrations. All the concepts represented are logically interconnected. It is a dynamic model to implement in different teaching/learning, assessing situations.

I am teaching Multilinguodidactics, Foreign Language Teaching Methodology and in my everyday practice I should consider different aspects of CEFR. I am working in different universities and I have to design different programs of teaching languages. I can use Qualimatrix in designing new programs and courses, planning new lessons, in developing new assessment criteria.
